Terms and Conditions of Consignments

You will be bound by these Terms and Conditions whether you read them or not.

- 1. The seller enters into this contract with Premier Livestock Auctions (PLA) doing business in Arkansas from the acceptance of the consignment into the current sale until the following terms and conditions have been fulfilled.
- 2. Consignment Forms must be accompanied by ORIGINAL REGISTRATION PAPERS AND SIGNED TRANSFER. If the consignment is a non-registered or "grade" horse the consignment fee must be paid in full at the time the Consignment Form is submitted.
- 3. Consignment fee is \$125 and is non-refundable and non-transferable. In addition to the consignment fee, the seller agrees to pay PLA 8% of the sale price on the final accepted bid. Seller understands the right to "pass-out" the horse at no additional fee. PO's must be acknowledged prior to the horse leaving the sale ring.
- 4. Seller agrees to authorize PLA to deduct all fees and/or expenses due from the proceeds of the sale. In the event of a deficiency, seller agrees to immediately pay PLA the balance due. If a consignment is submitted and prior to the sale the entry is withdrawn, the consignor is still required to pay the consignment fee in full.
- 5. Seller authorizes PLA to market and sell the consignment at public auction to the highest bidder and to receive and disburse the proceeds of said sale on seller's behalf.
- 6. An original COGGINS TEST dated within 6 months of sale and an original HEALTH CERTIFICATE dated within 20 days of sale must be submitted at the horse's arrival on sale grounds. There will not be a veterinarian on site on sale day to perform testing. Health certificate must include pregnancy status of bred mares, the status of descended testicles for stallions 13 months of age or older.
- 7. Seller is responsible for delivering all necessary paperwork to the sale office. The consigned horse will not be allowed to sell until all necessary paperwork is in the sale office. PLA will not guarantee any paperwork or other material associated with a consigned horse.
- 8. All defects, deformities and/or vices (i.e. navicular disease, foundered, cribbing, weaving, parrot mouth, proud cut geldings, cryptorchid, HYPP status, etc) must be announced when horse is presented for sale in the sale ring. Any unannounced deformity and/or vice has the right of return for 48 hours following the sale.
- 9. Due to limited stalls available, stall assignments will be given to completed consignments in the order they are received. In the event more consignments are received than stalls available, the remaining consignments will have no accommodations at all.
- 10. Premier Livestock Auctions reserves the right to determine when settlement to consignor of sale day proceeds will be made. Payment to the consignor can be performed after the Buyer's payment for purchase is deemed sufficient AND all paperwork pertaining to the sale of the horse is secured by PLA.
- 11. Seller agrees not to hold Premiere Livestock Auctions liable for the purchase price of the horse in the event the buyer defaults on the purchase.
- 12. Premier Livestock Auctions reserves the right to decline submitted entries not acceptable for the sale.
