International students and graduates do not need Permanent Residence to work in Australia. Students work rights vary from 40 hours a fortnight to full time depending on their visa. Their partners also have the right to work

Employing an international student or graduate is easy. You do not need to sponsor an international student or graduate to work for you, unless you chose one of the employer sponsored options

Making Sense of work rights and Visas

SUMMARY OF INTERNATIONAL STUDENT AND GRADUATE WORK RIGHTS:

STUDENT VISA HOLDERS:

- GENERALLY CAN WORK 40 HOURS A FORTNIGHT WHILE STUDYING & FULL TIME ON BREAKS.
- MASTERS OF RESEARCH & PHD CAN WORK FULL TIME.
- PARTNERS OF MASTERS & PHD CAN WORK FULL TIME.

GRADUATE VISAS HOLDERS: CAN WORK FULL TIME FOR BETWEEN 18 MONTHS TO 4 YEARS.

BRIDGING VISAS: WORK RIGHTS VARY. USUALLY FULL TIME WHILE WAITING FOR 485 VISA OR PR TO BE GRANTED.

Visas and work rights

Student Visas Subclass 500, 574,573,572

In 2016, the Department of Immigration simplified student visas reducing the number of visas subclasses to just one, the subclass 500 visa.

However there are still some students who were granted their visas before this change and may have one of other subclasses above.

International student and their partners are permitted to work between 40 hours a fortnight and full time. You can confirm work rights on **VEVO**.

485 Visas

After international students complete 2 years study in Australia they may be eligible for a 485 visa. 485 visas can be granted for 18 months to 4 years. The majority of 485 visa holders have 2 year visas.

485 visas have full work rights.

Graduates can work as many hours as the like on their 485 visas. You can confirm work rights on **VEVO**.





What is a bridging visa A?

The bridging visa A is useful for allowing the applicant to remain in Australia after their current visa expires and whilst their new visa application is being processed. Generally the conditions of the previous also apply to the bridging visa. That means if an international has completed their course and applied for a 485 visa they usually have full work rights until the 485 visa is granted. If a 485 holder has applied for Permanent Residence, they have full work rights until Permanent Residence is granted. You can confirm work rights on **VEVO**.



What are Employer Sponsored visas?

Employer sponsored visas allow employers to sponsor people from overseas who are qualified and have work experience in an occupation on a skills occupation list. There are three main types of employer sponsored visas

Temporary Employer sponsored Visa: Subclass 482 (TSS Visas). Replaced 457

Visas are usually granted for 2 to 4 years and can be renewed.

How do I sponsor an employee?

Step 1. TSS Standard Business Sponsorship (SBS)

Employer is required to have an approved Standard Business Sponsorship agreement

- Company must be lawfully operating and
- be in a sound financial position

Step 2. TSS 482 Nomination

- Employer must nominate occupation from relevant list
- Make a SAF contribution depending on company revenue
- Advertise the position
- Annual base salary no lower than \$53,900 & Australian Market Rate

Step 3. TSS 482 Visa

- Applicant must have a relevant qualification or work experience,
- Min. 2 years work experience in the same field, usually within last 5 years
- English language requirements
- MLTSSL: equivalent IELTS 5 in each STSOL: equivalent IELTS 4.5 in each

How long can a 482 visa be granted for?

186 visa

Employers may sponsor skilled professionals for permanent residence and commonly use either the Temporary Residence Transition (TRT) or Direct Entry (DE) streams:

Step 1. ENS 186 Nomination

- Company must be lawfully operating in Australia; and
- Be in a sound financial position
- Make a SAF contribution amount depends on company revenue
- Job offer to applicant for min 2 vears
- Genuine position

Step 2a ENS TRT

18 April 2017:

- Australian market rate
- Nominate either the TRT or Direct Entry (DE) stream

Scheme (RSMS) 187 Visa

Similar to the ENS program. Employers with a business in a regional area have a greater list of occupations.

Step 1. RSMS 187 Nomination

- Company must be lawfully operating in Australia; and
- Be in a sound financial
- Make a SAF contribution amount depends on company revenue
- min. 2 years
- Genuine position
- Nominate either the TRT

Employer Nomination Scheme (ENS) Regional Sponsored Migration

- position
- Job offer to applicant for
- Australian market rate
- or Direct Entry (DE)

Step 2a RSMS TRT

For 457/TSS visa holders lodged after 18 April 2017:

- Nominate occupation from 187 MLTSSL/ROL list
- Work min. 3 years for nominating business on 457/TSS visa
- Be under 45 years at time of lodgement - may be eligible for exemptions
- English equivalent to IELTS 6 in each band - may be eligible for exemptions
- Health and Character

OR

Step 2b RSMS DE

- Nominate occupation from 187 MLTSSL/ROL list
- ANZSCO requirements for work experience depending on the nominated occupation
- Positive skills assessment required for some trade occupations
- English equivalent to IELTS 6 in each band - may be eligible for exemptions
- Be under 45 years unless exempt
- Health and Character
