This is a statement in which you are informed of the established safe diving practices for skin diving and scuba diving or snorkeling. Your signature is required as proof that you are aware of your assumption of risk and of the established safe diving practices. Read the statement prior to signing it. If you are minor, a parent or a legal guardian must sign this form.

I,....., for me and on behalf of my children of minor age hereby affirm that I have been well advised and thoroughly informed about the inherent risks of skin, snorkeling and scuba diving and that I am aware of the risks connected with diving and snorkeling. I further understand that snorkeling & diving sites might be remote by time or distance from a hyperbaric treatment facility. I declare further, that my physical and psychical abilities are not reduced by any illness and that my present health state makes a safe snorkeling / diving possible. I hereby personally assume all risks in connection with this dive / snorkeling trip for any harm or injury or damage that may result through my participation in any trips organized by Nooraya LLP, whether foreseen or unforeseen, and still to proceed with this diving / snorkeling charter in spite of the absence of a medical or hyperbaric treatment facility in proximity.

I understand and agree that, neither the dive guide, the crew, the boat, the travel agent nor Nooraya LLP. (further named as "parties discharged from liability"), can be held liable in any way for an any occurrence (injury, death, damages to me or my family, heirs or assign or estate) whatsoever. It is my intention by this instrument to exempt and release Nooraya LLP or its personnel and boat, or its properties from all liability whatsoever for personal injury, property damage or wrongful death caused by negligence on my behalf.

Beside this, I understand also that, diving / snorkeling on specific dive sites depends on the weather, sea conditions, local regulations and the experience of the divers. The dive guide has in respect thereof to consider the present situation and make a relevant decision. The dive guide is also entitled in special cases (e.g. infraction of dive / snorkeling regulations eventually legalities) to forbid a person to dive or snorkel. I, as a diver / snorkeler, am liable for observance of the dive guide advices and hereby affirm that I have to follow namely subsequent instructions:

- 1. Maintain good physical fitness for diving / snorkeling, avoid being under the influence of <u>alcohol</u> or dangerous <u>drugs</u> when diving or snorkeling. Be <u>healthy</u> and **not tired** before diving / snorkling.
- 2. Use complete, suitable, well maintained reliable equipment with which I am familiar. Inspect it for correct fit and function prior to every dive or snorkel.
- 3. Listen carefully to dive or snorkeling **briefings** and **directions** and respect the supervising of diving or snorkeling activities.
- 4. Know and obey local diving and snorkeling laws and regulations: **Don't feed fish**, don't touch anything under water, don't collect shells or other marine lives, and don't throw anything in the sea. Please protect the underwaterlife. Using of gloves is prohibid!

I understand the importance and the purpose of these established safe diving or snorkeling practices. I recognize that these rules are for my own safety and well being. Disobedience can be dangerous for me. I read the above statements before a sign them on behalf of my person, my family, my heirs and assigns.
