Sir,

I am directed to state that on the recommendations of the Western Regional Committee (WRC) which assessed the Institute, 1st August, 1992; the recommendations of the Standing Committee of the WRC at its 6th Meeting held on the 29th May, 1993 and 'the compliance report submitted by the Institute through the Western Regional Office on April 19th, 1993, the All India Council tor Technical Education (AICTE) has approved the setting up of the Taluka Vidhayak Samiti's Institute of Pharmacy, Nandurbar Nandurbar Dist. Purie Maharashtra to conduct the diploma course in Pharmacy with an intake of Aultorty) students with effect from year 1993-94.

The above approval is subject to fulfilment of the following Aconditions:

- The Trust shall provide land of about 3 acres and construct (1) a separate building in their campus for the Institute of Pharmacy including class rooms, laboratories, administrative facilities and other amenities library exclusively for the diploma course in Pharmacy as per AICTE norms.
- (2) The Trust shall provide adequate funds for construction of buildings, for purchase of equipments, laboratory works etc. and for recurring expenditure on the Institute as per AICTE norms.
- The Trust shall take immediate steps to appoint faculty (3) the Institute before commencement of the course.
- No new course shall be started in the Institute without the (4) prior approval of the All India Council for Technical Education (AICTE).
- the The intake of shall not be altered without (5) approval of the AICIE.

- (A) The AICTE Scales of Pay shall be introducted for the teaching and other staff.
- (7) The Management including the Governing Council of the Institute shall be constituted as per the AICIE quidelines and also the Chairman shall be appointed as oper the AICIE the AICIE guidelines.
- (8) The admissions shall be made on merit as per the guidelines issued, by the AICIE and no capitation or donation of any kind shall be charged for admissions.
- (9) That the tuition and other fees shall be charged as prescribed by the State Government within the overall criteria prescribed by the AICIE from time to time.
- (10) The the teaching staff shall be recruited on an All India basis by open selection, and as per procedure, qualifications, experience, etc. as prescribed by the AICTE from time to time. State-based selection would be permissible for such posts for which the State Government prescribes "State-based selection" as a general policy.
- (11) The accounts of the Institute shall be audited by a Chartered Accountant and be open for inspection by the AICTE or anybody authorized by it.
- (12) The Management and the Institute shall follow any further conditions to be laid down by the AICTE from time to time.

This approval is further subject to full compliance with the SCHEME as prescribed by the Supreme Court in its judgement dated 4.2.1993 on W.P. (C) No. 607 of 1992 with other WPs in the case of Unnikrishnan, J.P. and others etc. etc. vs State of Andhra Pradesh and etc. etc. and the related quidelines and criteria as may be issued by the AICTE, UGC or the Central Government from time to time.

In the event of non-compliance, by the Trust or the Institute with the above conditions, the AICTE will be free to take measures for the closure of the programme and withdrawal of its approval without consideration of any related issues and that all limitities due to closure would be that of the Trust and/or the Institute.

An Expert Committee of the Western Regional Committee (WRC) will visit the Institute by September, 1994 to assess compliance with the above conditions.
